# **3 DAY EDUCATION SEMINAR**

## **COURSES OFFERED:**

## Welcome to CUPW

This course gives new members key information about their union and helps them find their place in it. Topics include CUPW's history and constitution, how to write a resolution, union values versus employer values, understanding power, and the many faces of union activism.

## Solidarity Skills Level I

This course examines conflict in the union and how to handle it. Its aim is to equip locals with a solidarity skills toolbox to help prevent the escalation of conflicts and help resolve them when they do occur. Level 1 of Solidarity Skills introduces techniques such as active listening, non-violent communication, and conflict de-escalation skills. It focuses on different conflict resolution methods, and the development of communication skills used in this work.

#### **Grievance Handling**

This course reinforces participants' grievance knowledge, investigation and advocacy skills. Included: shop stewards rights, grievance investigation, active listening, grievance hearings, the duty of fair representation and the steward's role as a workplace organizer. In "It's more than grievances", participants look at shop floor-oriented strategies for resolving issues. Note: This course is for stewards with some experience.

#### **Fighting Back**

This course dispels the myth of membership apathy. Participants will learn how to organize and mobilize union members into a powerful force for change. The course explores how to do union work in a way that builds the strength and courage of the membership. The skills learned can be applied to all the tough situations facing our members and our union—it's a course for today and tomorrow.
